- 2. **ELIGIBILITY:** The Promotion is offered only to individuals who are legal residents of the United States, at least twenty-one (21) years of age of the individuals on the date of entry (each, an "Entrant"). 3. Limit: An Entrant may only create one (1) Account, whether before or during the Promotion Period, which Account is associated with the Entrant's unique and valid e-mail address provided during registration shall be deemed the eligible Entrant's "Official Email Address." Promotion Entities have no control over, and are not responsible for, any broadcast interruptions, errors or delays, or any programming decisions made by the Media Sponsor affecting the broadcast of RXP Prize Pods. In the event a specified RXP Prize Pod is not aired on a designated date or is delayed by more than sixty (60) minutes, cancelled, suspended or rescheduled, or if the Game Show is negatively impacted as a result of the performance of the Application or Sponsor's application host or related applications, Sponsor reserves the right to end the Game Show without selecting winning entries associated with that Game Show. After an Entrant has timely scanned a React QR code, or entered a valid React Code within the React App, Entrant shall be served a five-question multiple choice RXP Prize Pod Quiz, consisting of the following:

RXP Sponsor Quiz Questions: Entrant shall be served four (4) random multiple-choice RXP Sponsor Quiz questions about four (4) of the five (5) RXP Sponsors featured in the RXP Prize Pod. Quiz questions shall present a multiple-choice question concerning an important element or feature of a Sponsor's advertisement. B. Top Three (3) Weekly Qualified Winner Prizes: Each week, the three (3) Entrants to submit the most Qualified Winner Entries with a Grade of 100% without submitting any entries with Grades below 100% shall be awarded the following prizes:

1 st Place:	Five (5) RXP Prize Sponsor Prizes (ID's 1-5), with an ARV of \$2,850
2 nd Place:	Four (4) RXP Prize Sponsor Prizes (ID's 2-5), with an ARV of \$350
3 rd Place:	Three (3) RXP Prize Sponsor Prizes (ID's 3-5), with an ARV of \$100

In the event more than one (1) Entrant submits an identical number of Qualified Winner Entries without any Grades below 100%, the Entrant with the highest total combined Game Show Points during the Contest Cycle shall be the winner.
